Information for Quaker clerks

An important update about Quaker Life Representative Council

Quaker Life Central Committee, supported by the discernment of Quaker Life Representative Council Planning Group, has decided that now is the right time to lay down Quaker Life Representative Council (QLRC). This decision will be reported to Meeting for Sufferings in Spring 2026.

QLRC was created as a "two-way channel of communication for education, inspiration and consultation" and "so that Friends can share both spiritual and practical experience of living their Quaker lives" (Quaker faith & practice, 8.09). This sharing and communication is still vital, and the decision to lay down QLRC can be seen as an indication of the success of new ways of working and communicating, and a joyful opportunity to simplify structures.

Some of the ways Friends can continue to be involved in communication, education, inspiration and sharing our Quaker lives are:

- Yearly Meeting From 2026 there will be several sessions a year.
- Quaker Life networks for Outreach, Youth, children & families, Children and young people's events, Chaplaincy
- Connect with your Development worker
- Quake! weekly email newsletter and other newsletters and role-holder updates from Quakers in Britain and Woodbrooke
- Revising Quaker faith & practice
- One-off themed events like the Future of British Quakerism conference held in 2024 and this year's Radical Hearts, Open Minds days.

When is the next Yearly Meeting?

The next Yearly Meeting is 1-4 May 2026. It will be held online and in Friends House, London. Everyone is welcome. Everyone attending, whether online or at Friends House, will need to register. We expect registrations to open on **Monday 12 January**.

Junior Yearly Meeting, for Friends aged 15-18, will be held **3-7 April 2026** (see details below).

What will be on the agenda?

While the agenda for Yearly Meeting in May 2026 has not yet been finalised, we expect it to include discernment on aspects of these questions:

- In a divided world, what unites us as a Spirit-led community? How do we foster acceptance and belonging?
- As a Spirit-led community, how can we handle conflict well in a way that builds connections, nurtures community and finds common ground, overcoming divisiveness and polarisation?

Friends may wish to spend time reflecting on these questions in advance of Yearly Meeting, individually or in groups. We will offer some suggestions of activities to help Friends of all ages prepare for Yearly Meeting. We expect this to be published by **Friday 19 December**.

The agenda for Yearly Meeting in May 2026 will also include several reports and some changes needed to implement the decision we took at Yearly Meeting in 2024 to move from holding Yearly Meeting once a year to holding it four times a year.

We will hold online preparation sessions covering some of the topics due to be considered between **Monday 13 April and Friday 17 April 2026 starting at 7.30pm**. There will be more information about online preparation sessions nearer the time. Please put the dates in your diary.

Who decides what goes on the agenda?

The agenda for Yearly Meeting is decided by Friends on the Yearly Meeting Agenda Committee (YMAC), this is done through prayerful discernment. Friends on YMAC are of different ages and experiences and from different parts of Britain. YMAC is helped in its discernment by input from Friends on various Quaker committees and other bodies who share how the spirit is moving in their work. The leadings of these bodies help YMAC discern the Yearly Meeting agenda.

Call for appointments: Yearly Meeting representatives

From July 2026 all area meetings plus Crynwyr Cymru – Quakers in Wales, Quakers in Scotland and Young Friends General Meeting will be asked to appoint a Yearly Meeting representative.

Yearly Meeting representatives will help foster communication so that Friends in meetings can feel more connected to what happens at Yearly Meeting. The presence of representatives will also ensure continuity of attendance from session to session. Representatives will be asked to attend Yearly Meeting and to find ways to let Friends in their meetings know what is going on and encourage them to attend for themselves.

Quakers in Britain provides an order for burial form. This is an official document used when arranging a burial or for the interment or scattering of ashes. The document is now a stand-alone form and no longer part of a book. The form has been updated following feedback from Friends who use it. National Churches Trust – Survey Summary

Earlier this year the National Churches Trust (NCT) carried out a survey of churches across Britain. The survey was to help policymakers, the media, and the wider public better understand the challenges churches face and to highlight the vital work that churches do. Quaker meetings were encouraged to submit responses so that Quaker meetings are represented.

Quaker Asylum and Refugee Network (QARN) survey on refugee support

QARN is gathering information about how Friends are supporting refugees and people seeking sanctuary in the UK. They are asking Friends to complete this short questionnaire.

QARN hopes to learn more about the activities of individual Friends and Local Meetings, so they can help connect people, support this work, and strengthen our collective witness. They are interested in all kinds of involvement, from one-off learning events to ongoing projects, and will share a summary report next year.

Hope Grants

These are small grants to improve the quality of life of Quaker members and attenders who are unemployed or unable to make a living wage. Friends in financial need can apply for a grant of up to £750 towards items or activities that will improve their quality of life. The William Gunn's Charity welcomes requests for grants to assist individuals who are in Membership of the Religious Society of Friends in Britain and are experiencing financial need or hardship.

Grants cannot be to pay taxes and would not usually be for on-going payments. However, Friends may apply as often as is necessary, each request for a grant being taken as a separate and fresh application and dealt with on its merits.
