## Meeting for Sufferings 5 October 2024

Dear Friends,

It was a pleasure to meet you all, whether at Friends House or online, at the start of this final term of Meeting for Sufferings. I hope you found our session as rewarding as we did at the table.

We agreed in principle with Quaker Life Central Committee's recommendations for non-geographical membership options to be developed within Britain Yearly meeting's existing structures and asked them to develop concrete proposals to bring to Yearly Meeting. We also asked Quaker Life Central Committee to take responsibility for a working group to bring proposals for a revised text of the Quaker marriage declaration, to which we expect to return when that work has been done.


Outside the Quaker community, we considered the language that we use to describe the situation in Palestine and Israel. We were reminded of the importance of naming the situation as we see it, and agreed to align ourselves with the terminology of the International Court of Justice in describing the situation in occupied Palestine as one of apartheid and recognising the plausible risk of genocide in Gaza.

Also in relation to the world beyond Quakerism, we heard a report on the work of the Reparations Working Group. The Group provides a significant opportunity for Friends to find out more of the legacy of structural injustice in which our own Society is not innocent and would recommend that Friends throughout the yearly meeting engage with the Group's work. In the light of our business, I regret that we did not have time to hear the powerful call from the Friends' World Plenary Meeting expressed in their epistle, whose message that "with radical hope, we trust in our collective ability to 'recognise, repent, redeem and restore' and to work together in beautiful and transformative ways" speaks to me of the work we are called to do.

I look forward to meeting you again in December for our next session.

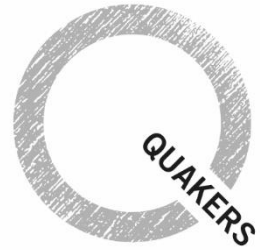

### **MfS/24/10/05 Quaker Recognised Bodies**

We agree to register 'Discovering Quakers' as a Quaker Recognised Body for a period of five years (to be reviewed in 2029).

We agree to re-register two existing bodies: 'Quakers and Business Group', and 'The Retreat', for a period of five years.

### **MfS/24/10/06 New ways of belonging**

We receive minute QLCC 24.38 from Quaker Life Central Committee (QLCC), and a paper to accompany it. Harry Albright, co-clerk of QLCC, has introduced the matter to us referring to the report and recommendations of the QLCC working group tasked with exploring new ways of fully including Friends for whom BYM's traditional geographical membership structures don't work, for whatever reason.

We have considered this matter and we welcome QLCC's discernment on the proposal for non-geographical membership, which can be accomplished within BYM structures. We hope that this work will help us think about the relationship Friends have with other Quaker bodies. We appreciate there will be substantial work to be done in working out the details before the proposals are ready for Yearly Meeting.

We thank Harry for speaking to us today and answering our questions.

### **MfS/24/10/07 Report from BYM Trustees**

We receive minutes from BYM Trustees' meetings in June, July and September. We have heard from Marisa Johnson, Clerk of Trustees and have had the opportunity to ask questions.

We note news on the developing relationship with Woodbrooke; reflection on the effective provision of support to area meetings; and learning from the experience of Friends engaged in developing new regional governance structures.

We have heard encouragement to support the yearly meeting financially as we are able.

We uphold trustees in their service.

### **MfS/24/10/08 Group to review central structures**

We have heard that the Group is currently consulting Friends prior to submitting a formal proposal to Yearly Meeting in 2025. We encourage representatives to publicise this work amongst Friends and to engage with the consultation process.

### **MfS/24/10/09 Our work in Palestine and Israel**

Further to minute MfS/24/06/09, we receive paper MfS 2024 10 11 which provides a report on discernment from Quaker Peace and Social Witness Central Committee (QPSWCC) on the use of the terms genocide and apartheid in relation to the current conflict in Palestine and Israel.

Our twin roles as prophets and reconcilers may be difficult to balance. We reaffirm that ultimately our task is to engage in peace building focused on ending the illegal occupation and seeking justice for all who live there and the surrounding region, however we note that in this situation our primary role is to bear witness. "The first skill [in addressing conflict] is naming: being clear and honest about the problem as I

see it" (*Quaker faith & practice* 20.71). We note the recommendation that we should align with the International Court of Justice rulings that the term apartheid is an accurate description of the situation in occupied Palestine and that there is a plausible risk of genocide in Gaza. We accept this advice as honouring our commitment to speak truth in love. As George Fox said, "My allegiance lies in truth and faithfulness" (*Quaker faith & practice* 19.37)

We also note the increasing tensions in our own society, where some faith communities face significant hostility, and that we have significant work to do in supporting interfaith relationships here. "Let all things be done for building up", (1 Corinthians 14:26). We recognise that additional work may require the commitment of additional resources.

### **MfS/24/10/10 Reparations Working Group**

We have heard from the Reparations Working Group and we are impressed by the progress it has made in its first year by approaching the task methodically, and when relevant working in conjunction with others, including area meetings and Woodbrooke.

Members of the group are keen to engage Friends with their work and are willing to talk to area meetings and share their findings so far about British Quaker involvement in transatlantic chattel slavery, colonialism, and economic exploitation. We have heard that Christine Habgood-Coote, the Meeting for Sufferings representative on the working group, has asked to be released from service. We agree to this request, with immediate effect. We will take the appropriate steps to find a member of Meeting for Sufferings to fill this role.

We thank the group for its report and Rita Remi-Judah for presenting it and answering our questions.

### **MfS/24/10/11 Marriage declaration**

Last December, Meeting for Sufferings received a paper from the Book of Discipline Revision Committee asking us to consider the wording of the marriage declaration (minute MfS/23/12/07). We receive over 50 minutes and contributions from area meetings, central committees and other bodies, and from individual Friends.

From the responses, it is clear that we are not yet of one mind on this matter, but that Friends have welcomed the opportunity to engage with it. We value the discernment so far.

We are not in a position to resolve this matter at this meeting, but it seems clear that there is a will take this forward.

We are clear that marriage, in Quaker understanding, is a commitment of the couple held in the Light witnessed by the supporting meeting.

We ask that a working group be formed under the auspices of QLCC to work further on the matter of wording and we will return to this matter at a later date.

We send this minute to QLCC.
